Prior to the above scheduled review hearing if it appears from a progress report that the defendant is <u>not</u> meeting the terms and conditions of the defendant's diversion program, the Court (or other agencies as set forth in section 1001.29) may set an interim hearing for modification or termination of diversion, with notice of hearing to be provided to defendant by the moving agency.

Any bail, bond, or undertaking deposited on behalf of defendant in this case is hereby ordered exonerated and the Defendant shall be placed on a Court Own Recognizance Agreement as executed this date.
